To obtain a special flight authorization, apply in the form of a letter, email, or fax. The unique application and issuance procedures are provided in FAA Order 8130.2, "Airworthiness Certification of Aircraft", Chapter 22, "Special Flight Authorizations for Foreign Civil Aircraft".

Special Airworthiness Certificate - Special Flight Permit

FAA Form 8130-6 is used to make application and FAA Form 8130-7, special airworthiness certificate, is issued to approve each flight. These certificates FAR 121 or FAR 135 certificate holders who do not have a continuous ferry authorization. This normally will be issued by their certificate holding district office (CHDO).

14 CFR § 39.25 - How do I get a special flight permit ...

(a) A special flight permit may be issued for an aircraft that may not currently meet applicable airworthiness requirements but is capable of safe flight, for the following purposes: (1) Flying the aircraft to a base where repairs, alterations, or maintenance are to be performed, or to a point of storage. (2) Delivering or exporting the aircraft. (3) Production flight testing new production ...

FAA Form 8130-6 The applicant or authorized agent must complete sections I through IV, as applicable, for the type of airworthiness certificate being requested. If the application is for a special flight permit only, sections II and VI, or II and VII, as applicable, must be filled out.

725 Application. Purpose of this form. This form is used to apply to CASA for a Special Flight Permit (SFP) to allow the operation of an aircraft that does not meet its airworthiness requirements but under certain circumstances, and for a particular intended purpose, the aircraft may still be capable of safe flight.

Special Flight Permit

The Authority may issue a special flight permit for an aircraft that is capable of safe flight but unable to meet applicable airworthiness requirements for the purpose of: Flying to a base where weighing, painting, repairs, modifications, maintenance or inspections are to be performed or to a point of storage;

The Canadian Aviation Regulations (CARs) require unmanned air vehicle (UAV) operators to apply for SFOCs so Transport Canada can ensure operators use their UAV reliably and safely.
